Local agreement for Child Development Services from the State of California, Department of Education, Child Development Division, for Peralta Child Development Services for 2008-09.

SPECIFIC BOARD ACTION REQUESTED:

A resolution to be adopted to certify the approval of the Governing Board to enter into this transaction with the California Department of Education for the purpose of providing child care and development services and to authorize the designated personnel to sign contract documents for Fiscal Year 2008-09.

ITEM SUMMARY: *(PLEASE DISCUSS THIS ITEM)*

Child Development Services at the College of Alameda, Laney College, and Merritt College, funded through the State Department of Education, Child Development Division for the period of July 1, 2008 through June 30, 2009. Each of the three Children's Centers is licensed to serve 110 children, ages 1-5 years. Currently each of the three Children's Centers serves children 3-5 years of age. Most of the parents are students with some children of non-student parents as well. Priority is given to children from low-income families. Continued funding through this contract will allow the three PCCD Children's Centers to continue to provide comprehensive child development services during periods when classes are in session.

BACKGROUND/ANALYSIS:

The Peralta Community College District Children's Centers have applied for and received similar funding from the State Department of Education for over the past 25 years.
