The Peralta Afterschool Pathways Initiative is a career building project targeting young adults ages 18 to 30 in the City of Oakland and Northwest Alameda County. PAPI will create a uniform youth development training continuum for unemployed and underemployed young adults in Oakland while linking them to ongoing career path training in Peralta Certificate and AA programs leading to an employer recognized vocational certificate, transfer to the California State University East Bay or other 4 year Baccalaureate granting institution. Funding for this award is \$300,000. The chancellor recommends approval. Funding Agency: State Chancellor's Office, Sacramento.
