The Regions 3 and 4 Tech Prep Regional Consortium, consisting of Peralta Community College District (lead agency) and 14 other community college districts in Region 3 and Region 4, are pleased to present the following Tech Prep Regional Coordination Project application to the California Department of Education (CDE). Specifically, the Consortium is requesting a CDE grant not to exceed \$600,000 in order to strengthen and coordinate regional workforce development activities in Regions 3 and 4. The award will be used to establish an active and ongoing regional partnership of educational, business, and workforce development institutions committed to engaging in a collaborative regional approach to align career training education and pathway programs with the emerging workforce development needs of industry partners in Northern California. The Chancellor recommends approval.






