Request Authorization to apply for funding with United Way Green Tech Training Initiative, and Peralta Community College District, Laney College

ITEM SUMMARY: *(PLEASE DISCUSS THIS ITEM)*

Peralta proposes a new Green Tech training initiative that will expand current vocational training programs in construction and environmental control technologies at Laney College to create three new career pathways targeting "Green Collar" jobs in Oakland and surrounding communities. These will include green training pathways in green construction, home and commercial energy audit/retrofit, and green HVACR installation and retrofit. These new training components will result in the implementation of new curricula, new employer and industry driven training relationships, and the development of contextualized job readiness, case management, and basic educational skills training. The amount to be funded shall not exceed \$100,000. The Chancellor's recommends approval. Funding Agency: United Way.
