NONRESIDENT TUITION FEES**

WHEREAS, nonresident tuition fees are set annually for students attending community colleges; and

WHEREAS, the responsibility for setting such fees has been transferred to the local governing boards of California Community Colleges by revision to Education Code Section 76140; and

WHEREAS, computations by the District have been made as prescribed by the State in this revised section;

NOW, THEREFORE, BE IT RESOLVED that the nonresident tuition fee for fiscal year 2013-2014 commencing July 1, 2013, for Peralta Community College District students be set at \$213.00 per semester unit; and

BE IT FURTHER RESOLVED that the nonresident tuition fee will not be waived without specific board action.

**Resolution No. 12/13-22  
NONRESIDENT CAPITAL OUTLAY FEES**

WHEREAS, the District is authorized under Education Code Section 76141 to charge nonresident students who are both citizens and residents of a foreign country, nonresident capital outlay fees; and

WHEREAS, such fees are not to exceed the amount that was expended, per full-time equivalent students for capital outlay in the preceding fiscal year, and

WHEREAS, computations by the District have been made as prescribed under Education Code Section 76141;

NOW, THEREFORE, BE IT RESOLVED that the nonresident capital outlay fees for fiscal year 2013-2014, is set at \$6 per semester unit for a maximum of \$144 per year; and

BE IT FURTHER RESOLVED that the nonresident capital outlay fees will not be waived without specific board action.
