ITEM TITLE: Sunshining of Initial Proposal for Contract Re-Openers for SEIU Local 1021 to Peralta Community College District

SPECIFIC BOARD ACTION REQUESTED: In accordance with the Collective Bargaining Agreement for Hourly Employees between the Peralta Community College District and Service Employees International Union (SEIU), Local 1021, SEIU Local 1021 hereby makes official notice for re-openers for Articles IX (Pay and Allowance), X (Health and Welfare, and XIX (Reopeners) as well as three non-economic re-openers, for the Successor Agreement dated July 1, 2012 - June 30, 2015.

The initial proposal suggests that if any represented/unrepresented employee group/and or other bargaining unit receive a wage increase, Peralta Community College District agrees to increase the salary schedule for SEIU Local 1021 members.

Pursuant to Government code Section 3547, public comments on such proposal shall be received at the next regular Governing Board of April 9, 2013.
