ITEM TITLE:

Request approval to submit a proposal to apply for continued funding from the California Community Colleges for the Tech Prep Program.

SPECIFIC BOARD ACTION REQUESTED:

Request approval to enter into a grant agreement with the State Chancellor's Office.

ITEM SUMMARY:

Tech Prep education is an articulated, planned sequence of study beginning in high school, and extending through at least two years of postsecondary education or a apprenticeship program. Programs can continue up to the Baccalaureate degree.

This project supports articulation of courses and programs linking high school academy program, Regional Occupational Programs (TOP), and related career-technical programs. The project also funds career-technical curriculum and program development activities at both high school and community college as well as staff development activities for community college and high school instructors and counselors.

The amount of the grant agreement shall not exceed \$270,000.
