Request approval to submit a proposal to apply for continued funding from the California Community Colleges for The Perkins Title IC Funds (Now CTE: Career Technical Education, formerly known as VTEA: Vocational Technical Education)

SPECIFIC BOARD ACTION REQUESTED:

Request approval to enter into a grant agreement with the State Chancellor's Office.

ITEM SUMMARY:

Funds made available to eligible recipients are used to support career and technical education program that:

- Strengthen academic and technical skills of students;
- Link secondary and postsecondary CTE program (at least one program of study);
- Provide students with strong experience and understanding all aspects of an industry;
- Develop, improve, and expand use of technology;
- Professional development;
- Evaluate programs with emphasis in meeting need of special populations;
- Initiate, improve, expand and modernize quality programs;
- Provide services and activities of sufficient, size, scope and quality;
- Provide activities to prepare special populations for high skill, high wage, or high demand occupations leading to self-sufficiency

The amount of the grant agreement shall not exceed \$1,009,634.

The Chancellor recommends approval.
