The Peralta Community College District is applying for the following TRIO grants: Disability, English as a Second Language (ESL), Science, Tech., Engineering, and Math (STEM), and Health Sciences. The Federal TRIO Programs are educational opportunity outreach programs designed to support students from disadvantaged backgrounds. Eligibility is being determined for all campuses. The estimated amount per grant is approximately \$200k per year, per campus for five years. Faculty meetings are being organized for the appropriate input for grant development.
