**ITEM TITLE:**

Memorandum of Understanding (MOU) between Peralta Community College District (Peralta) and Solar Richmond.

**SPECIFIC BOARD ACTION REQUESTED:**

Request Approval for a Memorandum of Understanding (MOU) between Peralta Community College District (Peralta) and Solar Richmond.

**ITEM SUMMARY:**

In order to support the goals and objectives of the East Bay Green Job Corps (EBGJC), a Federal Reinvestment Act and Governors WIA 15% funded grant initiative administered through the California Employment Development Department, Solar Richmond will provide the following services:

1. Provision of Solar Principles training for all three (3) EBGJC bridge programs, to be provided over one week of the bridge training program, in collaboration with Rising Sun Energy Center.
2. Provide supervision of Solar Marketing paid internships for all three (3) EBGJC bridge programs, ensuring that all participants under Solar Richmond's supervision participate in 100 hours of paid community service.
3. To participate in the local implementation teams for all three (3) EBGJC bridge programs in Oakland, Berkeley, and Richmond. That includes participation in planning meetings, coordination of outreach, and other tasks as agreed upon in the local implementation teams for successful implementation of each bridge program.
4. To participate in ongoing curriculum development and planning for core bridge elements including job readiness, hard skills straining, and basic skills contextualization.
5. Provide appropriate documentation as needed to allow enrollment of trainees into the State EDD Job Training Automation system for this grants.
6. Comply with all activity requirements and mandates of the State of California Employment Development Department, including reporting of participant activities, outcomes, and compliance with state requirements for use of California Green Job Corps branding.

Total amount shall not exceed \$90,000. The source of funds is the East Bay Green Job Corps. The Chancellor recommends approval.
