Workability III Project, Laney College.

**SPECIFIC BOARD ACTION REQUESTED:**

Request Authorization to Apply for Continued Funding from the California Department of Rehabilitation for the Workability III Project at Laney College.

**ITEM SUMMARY:**

The Laney College Disabled Students Programs & Services (DSP&S) will combine staff and resources with the Workability III Project to provide vocational rehabilitation services to Laney College students who are Department of Rehabilitation clients.

Career planning, employment preparation, job search instruction, employment services, and on-going support activities will be provided to Laney students up to 90 days after job placement. These services will include full-time & part-time job placement for students who are attending classes. The primary focus will be on full-time matriculating students.

The Department of Rehabilitation works in partnership with stakeholders to provide services to individuals with disabilities.

The amount funded shall not exceed \$487,122 over a three year period. The Chancellor recommends approval. This is an ongoing project.
