Item Title:

Request approval for to receive \$425,000 from the City of Richmond. The College of Alameda will partner with the City of Richmond, Contra Costa Community College District and other community based organizations to train young adults to perform clean jobs.

Specific Board Action Requested:

Item Summary:

PCCD will perform the following services:

- Act as the primary agency responsible for implementation of day-to-day operations;
- Identify an individual to act as the project director;
- Assemble the grant implementation team and schedule regular meetings of the project leadership team;
- Develop and oversee subcontracts; add additional project partners as needed.

The funding period is 10/01/2009/-6/30/11

The funding available is \$425,000

The Chancellor recommends approval.

Background/Analysis:

The \$3,000,000, three-year project will:

- 1) Extend green building education opportunities to additional students;
- 2) Support the ongoing evolution of the green building course of study, adding and adapting new courses as needed;
- 3) Develop partnerships with existing training organizations to extend training to contractors seeking soon to be required certifications, including HERS II and BPI certification.
