SPECIFIC BOARD ACTION REQUESTED:

Approval of Resolution 9/10-47, Acceptance and Retention, Electrical and Data/Telecom Related Upgrades to Portables at Laney College, Dan Electric.

ITEM SUMMARY:

On October 14, 2008, this Board awarded a contract to Dan Electric for the Electrical and Data/Telecom Related Upgrades to Portables at Laney College. The work has now been completed, the Notice of Completion has been filed with the County of Alameda, and the Laney President and Business Manager have signed the Project College Acceptance Form. Board of Trustees acceptance is recommended. This resolution accepts the work as complete and provides for a retention payment of \$6,400.00, which is 10% of the original contract price (\$64,000.00). There were no change orders to this contract.

BACKGROUND/ANALYSIS:

This project is one of the previously approved Laney College Modernization and Short-Term Projects, funded by Measure A. The modernization and short term project allocations were discussed by the Board Facilities and Land Use Committee and approved by the Board of Trustees at the meetings of March 13, 2007 and October 9, 2007.



WHEREAS, the Project Manager employed by the Board to supervise the completion of said work, has certified in writing to this Board that said contractor completed the work heretofore described and has recommended to this Board the final acceptance of the project; and

NOW, THEREFORE, BE IT RESOLVED that said work of said contract be and the same is hereby accepted; and

BE IT FURTHER RESOLVED that the retention payment in the amount of SIX THOUSAND FOUR HUNDRED AND NO/100 DOLLARS (\$6,400.00), which is ten percent (10%) of said contract price, as modified by Change Order No. 1, shall be made thirty-five (35) calendar days from and after the filing of the Notice of Completion at the Alameda County Recorder's Office, provided no withhold notices requesting the withholding of any monies from said contractor have been filed with this Board of Trustees in accordance with the provisions of Title 15 of Part 4, Division 3, of the Civil Code of the State of California.




