ITEM TITLE:

Request Approval for a Contract Extension with Wisdom Info Tech – District Office (Educational Services).

SPECIFIC BOARD ACTION REQUESTED:

Request approval for a contract extension with Wisdom Info Tech to provide consultant services to PCCD's Business Intelligence (BI) Project. The amount approved shall not exceed \$40,000. This will cover expenses from July 1 – December 31, 2010.

ITEM SUMMARY:

The project (scope of work) focuses on three specific deliverables:

- A build-out of the Data Warehouse designed to scale outward as the demand for specific reports grows in the Peralta District;
- Fully develop accurate reports that can be accessed using the Oracle Business Intelligence Enterprise Edition (OBIEE) Suite by licensed users; and
- Build an interface for advance users to obtain raw data for additional ad-hoc analyses using Excel and other office applications.
