ITEM TITLE:

Consider Approval of Resolution 09/10-50, Accept Bid and Award Contract, Building E Improvements at Merritt College (Bid No. 09-10/30), BHM Construction, Inc.

SPECIFIC BOARD ACTION REQUESTED:

Approval of Resolution 09-10/50, Accept Bid and Award Contract, Building E Improvements at Merritt College (Bid No. 09-10/30), to BHM Construction, Inc., in the amount of \$727,709.

ITEM SUMMARY:

This project involves demolition of existing flooring, bleachers, storefront system, and paving; and installation of new interior modifications including flooring, bleachers, storefront system, refinishing exterior surfaces, new paving and restriping.

A formal bid was conducted for this project (Bid No. 09-10/30), and a bid opening was held on April 29, 2010. Nine bids were received, as follows:

The lowest responsible and responsive bid was submitted by BHM Construction, Inc., in the amount of \$727,709. This resolution formally accepts the bid and authorizes the contract award to BHM Construction, Inc., for Building E Improvements at Merritt College (Bid No. 09-10/30).

BACKGROUND/ANALYSIS:

This is one of the previously approved Merritt College Modernization and Short-Term projects, funded by Measure A. The modernization and short term project allocations were discussed by the Board Facilities and Land Use Committee and approved by the Board of Trustees at the meetings of March 13, 2007 and October 9, 2007.

Bid information for this project was published in newspapers of general circulation and ethnic publications reflecting the diversity of the market area. Bid information was sent to all Chambers of Commerce within the market area to disseminate to their constituency, local plan rooms and associated contractor subscription services.

WHEREAS, nine bids were received in response to said advertisement on the 29th day of April, 2010; and


WHEREAS, this Board does hereby accept the bid of BHM Construction, Inc.; and

NOW, THEREFORE, BE IT RESOLVED that this Board does hereby accept the bid of BHM Construction, Inc., 522 Walnut Avenue, Vallejo, California 94592, for Total Bid in the amount of SEVEN HUNDRED TWENTY-SEVEN THOUSAND SEVEN HUNDRED NINE AND NO/100 DOLLARS (\$729,709.00); making the total contract price SEVEN HUNDRED TWENTY-SEVEN THOUSAND SEVEN HUNDRED NINE AND NO/100 DOLLARS (\$729,709.00); and

BE IT FURTHER RESOLVED that the bids of the other bidders shall be and the same are hereby rejected; and

BE IT FURTHER RESOLVED that the Secretary of this Board be and he is hereby authorized and directed to enter into a contract in accordance with law with said BHM Construction, Inc. for the Building E Improvements at Merritt College (Bid No. 09-10/30), and the bid bond of said bidder be returned to it upon the acceptance of said contract together with the bonds attached thereto.
