ITEM TITLE:

Request Approval to Submit a California Department of Rehabilitation (DOR) Grant Application for pre-vocational and vocational training for students with Intellectual Disabilities (ID) for the College of Alameda.

SPECIFIC BOARD ACTION REQUESTED:

The purpose of the grant is to support DSPS students with pre-vocational and vocational training through on-campus inclusive training and other related support services.

The College of Alameda (COA) will request \$250,000 per year for three years. COA will work in partnership with their One-Stop, industry employers and specialized non-profits to implement this grant. COA has a program that already implements many of the program components through their Workability grant program.

ITEM SUMMARY:

COA in partnership with their One-Stop and community-based organizations will work with DSPS students to provide inclusive career technical education courses, contextualized basic skills, student support services, job development/placement services and job coaches. If funded, the first year will be used for planning. The Department of Rehabilitation has also indicated that the grant may be renewed if grantees are successful in program implementation.
