ITEM TITLE:

Consider Approval of Contract with CSU Fresno Foundation for Work to be preformed against Project Number 0828.

SPECIFIC BOARD ACTION REQUESTED:

Approve a contract with CSU Fresno Foundation not to exceed \$44,634 for the period for July 1, 2010 through June 30, 2011.

ITEM SUMMARY:

Peralta has been instructed by the State Chancellor's office to enter into a contract with CSU Fresno Foundation for authorized services. Funding for this Grant is Economic and Workforce Development Program Grant 09-323-001. The amount approved shall not exceed \$44,634, the maximum amount expected to be paid under the contract.

BACKGROUND/ANALYSIS:

Approval is sought for CSU Fresno Foundation to render services for Project Number 0828, which is a Grant (Economic and Workforce Development Program Grant 09-323-001) funded by the State Chancellor's Office in the amount of \$291,191. This Grant was originally to provide support and website management for the Economic and Workforce Development Program and was approved by the Board on February 24, 2009.

Subsequently, the State Chancellor's office has directed that some of these funds be redirected for work performed for Caltrans. \$129,883.71 remains unspent as of September 28, 2010. The State Chancellor's office is requesting that Peralta enter into a contract with CSU Fresno Foundation in the amount of \$44,634 for work for Caltrans.
