Independent Contract for Men of Valor

SPECIFIC BOARD ACTION REQUESTED:

Consider Approval of Independent Contract for Men of Valor

ITEM SUMMARY:

Men of Valor will provide a full-time case manager, on site supportive services including GED, computer literacy skills, transportation, legal assistance, housing, substance abuse and mental health services, job placement and retention services for approximately 40-45 clients. Men of Valor will also provide housing and food for 20 program participants at their facility. The first year will total \$139,500. The contract total amount to be approved is not to exceed \$418,500.

BACKGROUND/ANALYSIS:

Men of Valor is dedicated to modeling and replicating manhood. Their mission is to build confidence, boldness and enthusiasm to equip men to overcome the challenges they are confronted with on a daily basis in order to make a difference. Men of Valor brings men together as enthusiastic role models, eager to share their experiences with other men and train young men with leadership skills.
