Consider approval of a contract with Alameda County Workforce Investment Board for \$125,000 for Laney College to provide customized training for displaced workers in the field of medical device technology.

ITEM SUMMARY: *(PLEASE DISCUSS THIS ITEM)*

Under a contract with Alameda County Workforce Investment Board for \$125,000, Laney College will provide customized training for displaced workers in the field of medical device technology. Laney will provide customized training in Electrical Theory and Electronics, SolidWorks with Rapid Prototyping, Medical Device Engineering Technology, Computer Literacy, and Pre-employment training. Internships in industry structured through Cooperative Education will also be provided. The program of study will run from May, 2011 to end of summer 2011. Laney will partner with the UC Berkeley Department of Bioengineering to provide access for students to advanced equipment including molecular analytics and nanotechnology.

The contract is part of the Peralta District's effort to provide contract education opportunities for customized training for displaced workers.






