This item is a revision to ICC #17991 between the Workforce Collaborative and the Peralta Community College District. The revision includes funding for services that The Workforce Collaborative will provide on the EDD Clean Energy grant #127. The increase to the ICC is \$153,800. This ICC amendment also concerns The Workforce Collaborative: Project #1845 for a total of \$158,969; Project #1948 for a total of \$146,000 and with this amendment, Project #1947 for a total of \$153,800. The grand total of all three projects is \$440,569. The Workforce Collaborative is a partner organization providing intake, assessment, case management and job development and placement activities for this project.
