ITEM TITLE:

Department of Rehabilitation Addendum

SPECIFIC BOARD ACTION REQUESTED:

Consider approval to amend the Department of Rehabilitation Grant funding not to exceed \$145,000. The original amount funded for fiscal year 2011-2012 is not to exceed \$664,581, for a new amount not to exceed \$809,581. The original Board item was approved on July 21, 2009.

ITEM SUMMARY:

Approval is requested to amend the Department of Rehabilitation Grant funding not to exceed \$145,000. The original amount funded for fiscal year 2011-2012 is not to exceed \$664,581, for a new amount not to exceed \$809,581. The Greater East Bay District of the Department of Rehabilitation and the College of Alameda combine to provide vocational rehabilitation services to students under the Workability III program. The grant term is from July 1, 2009 through June 30, 2012. All Board approved contracts are subject to final negotiation and execution by the Chancellor. The Chancellor recommends approval.

SOURCE OF FUNDS (AND FISCAL/BUDGETARY IMPACT):

Department of Rehabilitation

BACKGROUND/ANALYSIS:

The Greater East Bay District of the Department of Rehabilitation and the College of Alameda combined resources to provide vocational rehabilitation services to students. Under the Cooperative Contract, College of Alameda Workability III Program provides program administration and management, counseling, case coordination, and employment services, and on-going support activities to students for 90 days after job placement. These services include interim part-time placement for students at COA who are attending classes to get training necessary for attaining their employment goals. All students attending Vocational Living Skills classes at COA are approved to work with WAIII. For fiscal year 2011-12 150 unduplicated students shall receive services under this agreement.


Resolution 09/10-1
