Request approval of an increase in the College to Careers grant award at the College of Alameda from \$750,000 to \$1,000,000.

The grant purpose is to support DSPS students with pre-vocational and vocational training through on-campus inclusive training and other related support services. COA will work in partnership with their One-Stop Business and Career Center, industry employers and specialized non-profits to implement this grant. COA has a program that already implements many of the program components through their Workability grant program. COA will review the possibility of working with other campuses in the second or third year of funding. All Board recommended contracts are subject to negotiation and execution by the Chancellor. The Chancellor recommends approval.
