ITEM TITLE:

Consider Approval of Resolution 11/12-36, Acceptance and Retention, Peralta TV Building Package, Enviroplex, Inc.

SPECIFIC BOARD ACTION REQUESTED:

Approval of Resolution 11/12-36, which formally accepts the Peralta TV Building Package project as complete and provides for a retention payment to the contractor, Enviroplex, Inc.

ITEM SUMMARY:

On September 28, 2010, this Board ratified the contract award to Enviroplex, Inc. for the Peralta TV Building Package. The work has now been completed and the Notice of Completion has been filed with the County of Alameda. Approval by the Board of Trustees is recommended. This resolution accepts the work as complete and provides for a retention payment of \$23,765.63, which is 10% of the contract price.

SOURCE OF FUNDS (AND FISCAL/BUDGETARY IMPACT):

Measure A, as approved by the voters in Peralta's constituency and authorized under Resolution 05/06-45, Exhibit A-1, District-Wide Projects, "Classrooms and facilities to enhance the community outreach capabilities of the District among the numerous ethnic communities living in and served by the District," and "Technology infrastructure for distance learning."

BACKGROUND/ANALYSIS:

The Board previously ratified one change order to this contract in the amount of \$13,995.26, which is 6.3% of the original contract amount (\$223,661.00).

DELIVERABLES/SCOPE OF WORK:

The project provided two modular structures to house Peralta TV at the District Administrative Center site.

ANTICIPATED COMPLETION DATE:

The work has been completed.

ACCEPTANCE AND RETENTION**

**PERALTA TV BUILDING PACKAGE
ENVIROPLEX, INC.**

WHEREAS, Enviroplex, Inc., a corporation existing under and by virtue of the laws of the State of California, the contractor under that certain contract with the Peralta Community College District, Alameda County, State of California, for all labor, materials, mechanical workmanship, transportation, equipment and services necessary for the Peralta TV Building Package, has made application for acceptance of the work; and

WHEREAS, the Project Manager employed by the Board to supervise the completion of said work, has certified in writing to this Board that said contractor completed the work heretofore described and has recommended to this Board the final acceptance of the project; and

NOW, THEREFORE, BE IT RESOLVED that said work of said contract be and the same is hereby accepted; and

BE IT FURTHER RESOLVED that the retention payment in the amount of TWENTY-THREE THOUSAND SEVEN HUNDRED SIXTY-FIVE AND 63/100 DOLLARS (\$23,765.63), which is ten percent (10%) of said contract price, as modified by Change Order No. 1, shall be made thirty-five (35) calendar days calendar days from and after the filing of the Notice of Completion at the Alameda County Recorder's Office, provided no withhold notices requesting the withholding of any monies from said contractor have been filed with this Board of Trustees in accordance with the provisions of Title 15 of Part 4, Division 3, of the Civil Code of the State of California.
