ITEM SUMMARY:

Under funding from the Department of Labor Community Based Job Training Grant for the ATLAS Program College of Alameda, for \$200,000, OD Network will provide recruitment, training/education and job placement services for students enrolled in the ATLAS program. This contract was held, pending approval of the DOL grant extension from 2/14/2012 to 3/1/2013. The ICC is now ready for execution based on prior verbal approval.

BACKGROUND/ANALYSIS:

Since 2006, OD Network has accessed over \$12,000,000 in funds to serve hundreds of companies including small Family-owned businesses to well-known Fortune 500 companies. They have placed over 4,000 dislocated workers into new positions and have assisted over 12,000 incumbent workers in retaining their positions and/or acquiring the skills necessary for advancement.
