ITEM TITLE: Consider Approval of Gateway to College Memorandum of Understanding with Oakland Unified School District – *Laney College*

SPECIFIC BOARD ACTION REQUESTED:

Consider approval of the renewal of the Memorandum of Understanding (MOU) between the Oakland Unified School District (OUSD) and the Peralta Community College District (Peralta) for Laney College to continue operating the Gateway to College (GTC) program.

ITEM SUMMARY:

OUSD, in partnership with Laney College, established GTC as an alternative high school in 2009, which serves students ages 16 to 20 who have dropped out of high school. Through the program, students are given a “second chance” and are concurrently enrolled at Laney College and OUSD, receiving both high school and college credit. Primary funding for the GTC will be based on the MOU with OUSD for Laney to provide instruction and student services to students in the program
