Consider Approval of the Deputy Sector Navigator Grant, College of Alameda

**SPECIFIC BOARD ACTION REQUESTED:**

The College of Alameda has received funding from the California Community Colleges Chancellor's Office, Division of Workforce and Economic Development, to support a deputy sector navigator program under the global trade and logistics sector.

The grant amount is \$300,000 from July 9, 2013 through June 30, 2014.

The College of Alameda (COA) proposes to establish a Global Trade & Logistics (GT&L) Deputy Sector Navigator (DSN) for the Interior Bay Area with the goal of providing a network of training resources to assist in promoting a skilled regional GT&L workforce. The DSN will convene and coordinate key partners in industry, education, and workforce and economic development by facilitating the development of effective GT&L partnerships and career pathways. By 2018\*, the DSN will oversee a system of structured and connected educational programs and support services that enable students to advance over time to better jobs and higher levels of responsibility in the growing GT&L sector. \*Note: If the first year's pilot is successful, there is an opportunity for the funding for this program to be extended.
