ITEM TITLE: Request Board authorization to approve a request by faculty member Mika Van Spanje to participate in the Reduced Workload Program (also known as “Willie Brown Act”) in accordance with California Education Code Section 87483 and Article 17 of the Collective Bargaining Agreement.

SPECIFIC BOARD ACTION REQUESTED: The Office of Human Resources and Employee Relations reviewed the request by Mika Van Spanje to participate in the Reduced Workload Program, and determined that Ms. Van Spanje meets the qualifications pursuant to Education Code 87483 as follows:

- Ms. Van Spanje is at least 55 years old.
- Ms. Van Spanje has been a full-time instructor for more than 8 years.
- Ms. Van Spanje has been employed full-time in an academic position for at least five years with no break in service.

ITEM SUMMARY: The request for a reduced workload by faculty member Mika Van Spanje meets the requirements of Education Code 87483. Board contract approval is subject to negotiation and execution by the Chancellor.

BACKGROUND/ANALYSIS: Ms. Van Spanje has been employed by the District since January 2006, when she was hired as a full-time Instructor at Merritt College.

Ms. Van Spanje’s request for a reduced workload at 100% shall become effective for Fall 2014 semester and 20% for the Spring 2015 semester. This request for approval of the Reduced Workload Program Agreement is in accordance with Article 27, paragraph C.1 of the Collective Bargaining Agreement which directs qualified employees to “initiate this procedure by formal written request to the Board of Trustees delivered to the College President.”
