Consideration of approval of a contract addendum with Stephanie Green for Berkeley City College.

Consider approval of a contract addendum for Stephanie Green in the amount of \$15,000, total contracted amount not to exceed \$35,000 (\$20,000 initially from Career Advancement Academy and \$15,000 from Carl D. Perkins for the 2014-15 fiscal year). Contractor provides workforce and professional development services for Berkeley City College's Public Health and Services (PHS) Learning Community in fulfillment of the project objectives of the Career Advancement Academy grant and in service of disadvantaged CTE students (Perkins funding objective). This addendum was required by the receipt, approval, and loading of the Carl D. Perkins grant after the creation of the original contract in summer 2014 funded with Career Advancement Academy grant funding.

SOURCE OF FUNDS (AND FISCAL/BUDGETARY IMPACT): Carl D. Perkins and Career Advancement Academy Grant, no impact on General Fund.

BACKGROUND/ANALYSIS:

Ms. Green has provided grant-funded workforce and professional development services to Berkeley City College's Public Health and Services Learning Community in fulfillment of grant objectives, including workforce development (relationship building and maintenance with over 100 community social service and healthcare providers), as well as onsite and one-on-one professional development support for BCC PHS students (ensuring students meet/exceed industry standards during work-based learning/internship placements and result in successful student performance and experience within these organizations).

DELIVERABLES AND SCOPE OF WORK:

Ms. Green will continue to provide workforce and professional development services to Berkeley City College's Public Health and Services Learning Community in fulfillment of grant objectives, including: (1) Developing and maintaining relationships with social service and healthcare providers to create, and continue, work-based learning placement/internship opportunities, and (2) Providing onsite and one-on-one professional development support to PHS students to ensure successful student work-based learning/internship placements.
