Consider approval of a contract for Georgia Piedmont Technical College (GPTC), in an amount up to \$142,260 funded by the National Science Foundation Advanced Technological Education (ATE) grant, to carry out activities in fulfillment of project objectives for Laney College's National Center for Building Efficiency for a Sustainable Tomorrow (BEST Center). GPTC is a sub-awardee of the BEST Center. On behalf of BEST Center, GPTC will host a Summer 2015 Instructor's Workshop on *Building Automation Systems Technology* and provide curriculum and lab exercise documentation; in addition, GPTC will promote the Center and participate in BEST Center's 2015 Winter Workshop and other industry advisory meetings.
