It is recommended that the Board of Trustees approve Resolution #14/15-22 for the 2015-16 Nonresident Capital Outlay Fee of \$6.00 per semester unit.

In addition to the nonresident tuition fee, Education Code 76141(A) states a community college district may charge to nonresident students an amount not to exceed the amount that was expended by the district for capital outlay in the preceding fiscal year divided by the total full-time equivalent students of the district in the preceding fiscal year.
