ITEM TITLE: Request Board Authorization to Increase Independent Contractor's Agreement for Professional Services for Liebert Cassidy Whitmore.

SPECIFIC BOARD ACTION REQUESTED: District administration requests Board authorization to increase an existing professional services agreement with Liebert Cassidy Whitmore in the amount of \$25,000 to provide legal services to the District. The District requests an increase by an additional \$50,000 for a contract not to exceed \$75,000 limit for fiscal year ending June 30, 2016. All Board-approved contracts are subject to final negotiation and execution by the Chancellor. The Chancellor recommends approval.
