Consider Approval to enter into an agreement with NetXperts for the installation of IT infrastructure at the Laney College BEST Center.

SPECIFIC BOARD ACTION REQUESTED:

Approval is requested to enter into an agreement with NetXperts, Inc. for the installation of IT infrastructure through a “piggy back” to the Foundation of California Community College Administrative Services Agreement (CB-15-013) in the amount not-to-exceed \$52,720.86.

The original design of the BEST center did not include full design & installation of the IT infrastructure. This contract fills that gap.

This work will integrate with the overall construction of the Laney College BEST Center and provide Phone & IT connectivity between the new facility and the Laney Campus / District infrastructure.

NetXperts will be responsible for the network infrastructure which shall include the mapping, pulling and connection of a 12 strand single-mode fiber cable between the IDF location at the BEST Center (location TBD) and the main server at Laney College (MDF). Server rack & equipment will also be installed at TBD location.
