SPECIFIC BOARD ACTION REQUESTED:

The amount to be funded is \$230,000 for the fiscal year 2008-2009. Funding is from the First Five Alameda County Agency (State Prop 10 funds). The Chancellor recommends approval.

ITEM SUMMARY: *(PLEASE DISCUSS THIS ITEM)*

The California Children and Families Act of 1988 (Proposition 10) created a program in the state with the purposes of promoting, supporting, and improving the early development of children from the prenatal stage to five years of age. The intent of this act is to enable counties to create and implement an integrated, comprehensive and collaborative system of information and services to enhance optimal early childhood development. The Strategic Plan, called Every Child Counts (ECC), is a key component to facilitate the development of the program to assist students who are working towards their AA degree. It is the Commissions' intent to assist local post-secondary institutions in their work to develop a motivated, component workforce to serve Alameda County families.
