ITEM SUMMARY: (PLEASE DISCUSS THIS ITEM)

Consider approval for Independent Contractor Agreement for Youth Uprising consulting services for East Bay Career Advancement Academy (EBCAA). The amount to be approved shall not exceed \$28,556. The mission of the Peralta Colleges includes the creation of educational opportunities for underserved young adults; and to accomplish that part of its mission, Merritt College, a participating Peralta College, desires to offer its EBCAA curriculum at Youth Uprising, a community-based organization, in order to make the program more accessible to the target population (18-30 year olds) in its service area. Youth Uprising service area has classroom space and experience providing skill development and case management services to young adults and has agreed to be the site for the Merritt College EBCAA program. The Chancellor's recommends approval. Source of funding: State Chancellor's Office, Sacramento.




