Approval of Resolution 07/08-56, Acceptance and Retention, Painting Handrails, Basketball Poles and Electrical Poles at Merritt College, Andy's Painting.

ITEM SUMMARY:

This resolution formally accepts the work of the contractor, Andy's Painting, as complete. This is one of the previously Board approved Merritt short-term projects.

BACKGROUND/ANALYSIS:

On September 18, 2007, this Board ratified a contract award to Andy's Painting for Painting Handrails, Basketball Poles and Electrical Poles at Merritt College. The work has now been completed, and the project manager recommends acceptance. There have been no change orders to this contract. This resolution formally accepts the work as complete and provides for a retention payment in the amount of \$4,865, which is 10% of the total contract price (\$48,650).

ACCEPTANCE AND RETENTION**

**PAINTING HANDRAILS, BASKETBALL POLES
AND ELECTRICAL POLES AT MERRITT COLLEGE
ANDY'S PAINTING**

WHEREAS, ANDY'S PAINTING, 2331 Carleton Street, Berkeley, California 94704, an individual ownership existing under and by virtue of the laws of the State of California, the contractor under that certain contract with the Peralta Community College District, Alameda County, State of California, for all labor, materials, mechanical workmanship, transportation, equipment and services necessary for the Painting Handrails, Basketball Poles and Electrical Poles at Merritt College, has made application for acceptance of the work; and

WHEREAS, the Project Manager employed by the Board to prepare plans and specifications for and to supervise the completion of said work, has certified in writing to this Board that said contractor completed the work heretofore described and has recommended to this Board the final acceptance of the project; and

NOW, THEREFORE, BE IT RESOLVED that said work of said contract be and the same is hereby accepted; and

BE IT FURTHER RESOLVED that the retention payment in the amount of FOUR THOUSAND EIGHT HUNDRED SIXTY-FIVE AND NO/100 DOLLARS (\$4,865.00), which is ten percent (10%) of said contract price, shall be made thirty-five (35) calendar days from and after the passage of this resolution, provided no withhold notices requesting the withholding of any monies from said contractor have been filed with this Board of Trustees in accordance with the provisions of Title 15 of Part 4, Division 3, of the Civil Code of the State of California.
